#### DISCHARGE OF PLANNING CONDITIONS

## LAND CONTAMINATION **ASSESSMENTS**

- Desk Study
- Intrusive Ground Investigation and Risk Assessment (Soil, Gas and Groundwater)
- Remediation
- Verification and Completion

Current UK legislation and planning policies require that land contamination assessments follow a phased, re-iterative approach. This identifies plausible sourcepathway-receptor linkages, and ultimately determines whether the land is suitable for the development for which it is proposed, or can be made suitable by remediation.

The need to provide an adequate land contamination assessment or site investigation is outlined in National Planning Policy Framework. The National Planning Policy Framework (NPPF) states that responsibility for securing a safe development rests with the developer and/or landowner.

With pressures growing on developers and landowners to tackle the problems associated with contaminated and derelict land, the need for specialist advice continues to grow. To meet this need Jomas Associates Ltd employs experts, who specialise in the investigation, remediation and redevelopment of contaminated land.

We manage our scope of works, to prevent unnecessary costs.

PDR - Prior Notification

## BASEMENT IMPACT **ASSESSMENTS & GROUND MOVEMENT ASSESSMENTS**

The construction of basements in new or existing developments is becoming more common, particularly across London and the South East.

The BIA process includes an assessment of ground conditions as well as surface water and groundwater conditions. The objective is to establish the impact of the proposed basement on surface and groundwater, and the potential for ground movements arising from the basement development as well as any impact on adjoining or neighbouring properties.

Ground Movement Assessments are undertaken in accordance with CIRIA C580/Burland damage criteria. We prepare a 3D model of the proposed basement and model the impact on adjacent buildings, structures and buried utilities, as required.

Jomas have completed many Basement Impact Assessments and Ground Movement Assessments for sites in Camden, Haringey, Hackney and Tower Hamlets, amongst other sites across London, Surrey, Kent and the Southeast of England.

#### TREE REPORTS

As arboricultural report providers, we place these recommendations within our reports in a format that the LPAs both like and understand, but we also endeavour to provide reports that can be understood and used by building contractors as well.

There are four elements to a report as follows:

- An arboricultural impact assessment.
- An arboricultural method statement.
- A tree constraints plan.
